# WHAT IS WETRANSFORM?

#### WeTransform is an EU-funded project awarded to a large consortium of 34 partners, coordinated by POLITECNICO DI TORINO.

It gathers stakeholders involved in transport automation and digitalisation activities, in the transport workforce representation, in activities related to decision-making methodologies, in academic research and in the representation of local and national authorities.

It aims to apply a participatory approach, using Collective Intelligence, to generate an evidence-based and action-oriented agenda for politicians to tackle the challenges imposed on the labour force by the increasing automation of transport.

# HOW DOES IT WORK?

WeTransform identifies key barriers, needs, skills, competences, examining best practices and facilitating the co-creation of targeted and durable solutions.

It supports collaboration through three main approaches:

- 1 Establish and foster a collaborative platform for the discussion of the effects of automation on transport labour with relevant stakeholders.
- 2 Co-create user-friendly and shareable knowledge related to automation impacts on the transport labour market.
- 3 Enable and support durable and effective dialogue on innovation and the reality of workforce requirements and conditions.

# The project has set-up three tools to apply these approaches:

The Living Hub Part of a collaborative ecosystem of networks and projects, where the main actors are the partners of WE-TRANSFORM. The living hub will include all actors covering the value chain of transport automation: key stakeholders of all transport modes (operators and industry), researchers, decision makers, trade unions and workers' associations. It will gather knowledge on best practices, challenges, and sectoral labour requirements.

**Stakeholder forum** Key players will connect and support awareness raising on key topics. They will co-design approaches and set priorities for collaborative research and actions. All stakeholders possibly interested to grow the network will be invited to participate, and meet in semi-annual workshops.

Advisory Board High-level experts of transport automation and digital services, from research institutes, academia, public companies, and private business stakeholders, collaborate to target the transnational development of the proposed services and advise on dissemination of outcomes.
